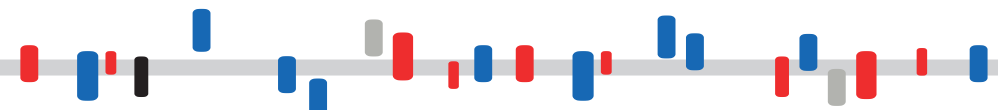

We have been promoting a large-scale project called "Fly High 2020," which is part of a challenge to become the world's best.

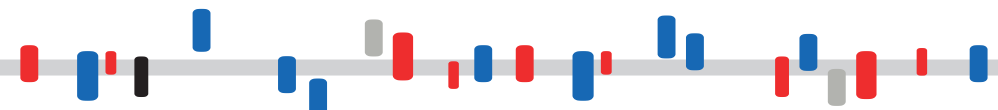

STEEL division

The Steel Division is responsible for the distribution and sale of steel products supplied by global steel makers. We extend our business areas by exploring new markets and establishing future-oriented bases through a win-win strategy and vicarious export & import.

Business area

Main tasks

- Purchase of products and materials from foreign steel companies
- Supply of products to domestic & foreign buyers
- Sale of steel scraps and finished products to steel manufacturers and distributors
- Intermediate trade between countries and vicarious export & import

Main items

- Finished products such as H-beams, rear plates, hot rolled coils, pipes and wire rods
- Half-finished products such as steel scraps, billet and slab

Major partners

- Domestic partners such as Hyundai Steel, Dongkuk Steel, Daehan Steel, Korea Steel Shapes, Daewang Steel and CN Steel
- Foreign partners such as Daiwa Steel, Chiyoda Steel, JFE Shoji, Tokyo Boeki and Bushan Steel

The Steel Division strives to meet the customers' needs through various business methods and become a global leader of the steel industry.



TEXTILE division

The Textile Division exports domestic/foreign yarns and fabrics to the US, Latin America and Europe through a multilateral sales network. It is also becoming a worldwide leading textile company through its efforts in vicarious export and domestic sales aside from intermediary trade, direct export and vicarious import.

Business area

Main tasks

- Intermediary trade (cross trade): sourcing of yarns and fabrics from foreign textile companies for export to the US, Latin America and Europe
- Direct export: sourcing of yarns and fabrics from domestic textile companies for export to the US, Latin America and Europe
- Vicarious import & export: commissioned import & export tasks targeting textile trading companies
- Stock sales: stock sale of commercial textile products

Main areas

- Textile products such as Yarns & fabrics for knits and garments

Main items

The Textile Division is operating its own warehouses in both domestic/foreign countries. It helps to consistently and rapidly supply and deliver goods to buyers



RESOURCE division

The Resource Division is targeting long-term profitability and growth in securing overseas energy resources. We will also work hard to grow as a specialized resource division by securing & supplying future energy resources.

Business area

Main tasks

- Purchase of iron & copper ores from foreign countries for supply to steel manufacturers
- Sourcing of iron/copper ores and manganese from foreign countries for export to China and Japan

Main items

- Coal, iron ores, copper ores, nonferrous metals and nonferrous scraps

Major partners

- Domestic partners such as POSCO, Hyundai Steel and LS-Nikko
- Foreign partners such as Wukuang Group, JFE Corporation, Nippon Steel Corporation and SINO Steel

The Resource Division exports high-quality materials to other countries through intermediary trade and domestic distribution. We are also creating a base for future resources business through the establishment of local subsidiaries.



CHEMICAL division

The Chemicals Division performs intermediary trade, direct export, and vicarious import of chemicals and chemical-related products. We are actively engaged in developing and maintaining long-term relationships with leading suppliers and customers throughout the world.

Business area

Main tasks

- Dealing with the required chemicals-related products through a business model (direct export and vicarious import)
- Cross Trade, direct export, and vicarious import

Main items

- Resin, BOPP, calcium chloride, refractory and ceramics

Major partners / channels

- Domestic & foreign chemical companies
- Domestic manufacturers and sourcing of foreign suppliers
- Extension of its partners through foreign subsidiaries in New York, Moscow and Frankfurt

The Chemicals Division will further develop into a corporation that pursues challenge and growth while becoming a competitive organization through sustainable market R&D.



GENERAL TRADING division

Business area

Main tasks

- Import of food resources and main industrial raw & subsidiary materials from foreign suppliers
- Direct export of electronics, IT products and plywood- Vicarious import and export in and outside of Korea

Main items

- Finished products such as electronics, IT products, prefabricated house, constructional & agricultural machine and new items
- Raw & subsidiary materials such as seamless pipes, copper alloy tubes, industrial tubes, LCD screens, plywood and new items
- Food resources such as corn fodder, sugar, flour and imported meat (beef and pork)

With the cooperation of foreign companies, The General Trading Division is now participating in various industries such as environment and info-communication all over the world. Together, we will succeed in the mission of 'Internal Sustainability & External Growth'.



INTEGRATED PURCHASING division

The Integrated purchasing Division provides a total service required for the company's operation. It includes the supply, distribution and sale of raw and subsidiary materials; total logistics (sea, air and inland); and MRO service.

Business area

Main tasks

- Integrated purchasing and supply of raw chemicals & subsidiary materials, automotive parts and MRO materials
- Global sourcing of raw materials, sourcing of domestic makers and alternative development of raw materials
- Distribution & sales of raw materials, vicarious export & import, marine transportation for export & import, operation of domestic distribution centers and transportation of container & bulk cargo

Main items

- Synthetic rubber, natural rubber, chemicals, rubber compound oil, carbon black, automotive parts, reinforced braid layer and connector
- Materials for maintenance, repair and operation, facility, mold tool and lubricating oil
- Operating distribution center, distribution & processing, domestic transport management and arranging marine multimodal transport

Major partners

- Kumho Polychem, Kumho Petrochemical, SK Global Chemical, GS Caltex, Hyosung, OCI, Hanil Chemical Ind., Kep, Korea Export Packing, Glovis and CJ GLS

The Integrated purchasing Division is providing an efficient distribution service with the standardization of tasks and specification of materials. In MRO service, we integrate the quantity of materials and seek to increase price competitiveness.





OVERSEAS division

The Overseas Division

procures and exports raw & subsidiary materials and machine equipment to foreign affiliates such as Hwaseung VINA and Chang-chun Shoes.

We also support the sourcing of raw & subsidiary materials for foreign factories; exporting of machines and facilities; dispatching of manpower to foreign factories; and general affairs.

Business area

Main tasks

- Sourcing of Korean materials such as raw & subsidiary shoes materials and machine equipment
- Support of foreign factories through the control of material quality/delivery time/unit price, development of brand & model, and dispatch manpower

Main items

- Raw & subsidiary materials for shoes such as rubber chemicals, adhesives, leather, synthetic leather, fabric and shoestring
- Machine equipment such as machines and facilities for production lines, tools & materials for engineering work, and development equipment

Major partners

- Hwaseung VINA: Located in Ho chi min, Vietnam. It is a core shoes OEM producing/developing products for Reebok and Adidas
- Changchun shoes: Located in Dailan, China. It produces Adidas brand shoes and its annual sales volume is about \$100 million

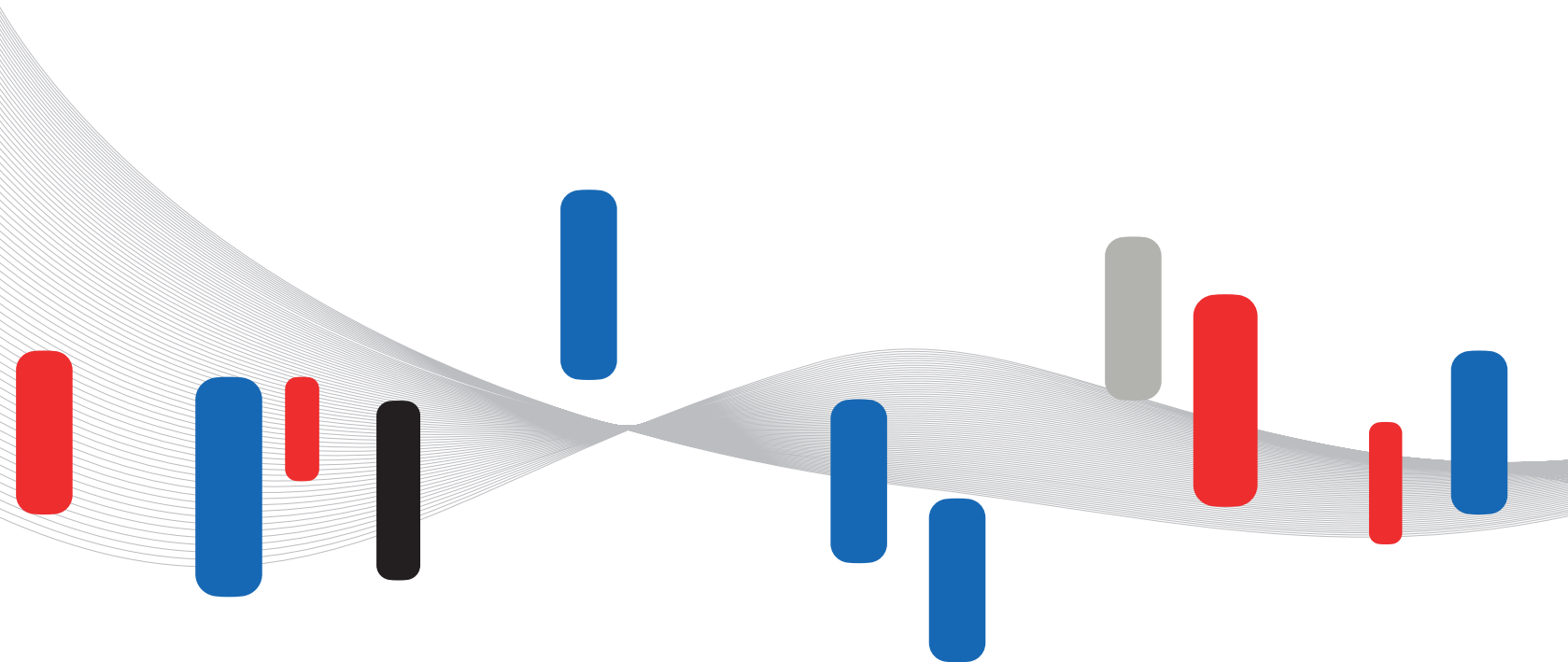
